**\*Affiliate members** as interpreted under Article 6 of the Constitution refer to State, Federal Territories and District Associations, Clubs and Academies that are registered under Sports Development Act Act 1997, approved by the Sports Commissioner, Ministry of Youth & Sports, Malaysia.

\* **Individual Members** (6.2) : Consists of members not exceeding five (5) persons appointed by the Main Committee (EXCO) and are entitled to voting rights and eligible for election.

\* **Associate Members** (6.3) Made up of Associations, clubs and organizations which carry on variety of sporting activities other than TKD, and legally registered in the law but are not entitled to voting rights.

\* **Honorary Members**(6.4): Individuals who have served the Assciation or individuals who can contribute to the Association appointed by the President/Exco.
